A BILL

 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "DOE and USDA Inter-
- 5 agency Research Act".

1SEC. 2. DEPARTMENT OF ENERGY AND DEPARTMENT OF2AGRICULTURE JOINT RESEARCH AND DEVEL-3OPMENT ACTIVITIES.

4 (a) IN GENERAL.—The Secretary of Energy and the 5 Secretary of Agriculture (in this section referred to as the "Secretaries") shall carry out cross-cutting and collabo-6 7 rative research and development activities focused on the 8 joint advancement of Department of Energy and Depart-9 ment of Agriculture mission requirements and priorities. 10 (b) MEMORANDUM OF UNDERSTANDING.—The Secretaries shall carry out and coordinate the activities under 11 subsection (a) through the establishment of a memo-12 randum of understanding, or other appropriate inter-13 agency agreement. Such memorandum or agreement shall 14 require the use of a competitive, merit-reviewed process, 15 which considers applications from Federal agencies, Na-16 tional Laboratories, institutions of higher education, non-17 profit institutions, and other appropriate entities. 18

19 (c) COORDINATION.—In carrying out the activities20 under subsection (a), the Secretaries may—

- 21 (1) conduct collaborative research over a variety
 22 of focus areas, such as—
- (A) modeling and simulation, machine
 learning, artificial intelligence, data assimilation, large scale data analytics, and predictive
 analysis in order to optimize algorithms for

purposes related to agriculture and energy, such as life cycle analysis of agricultural or energy systems;

4 (B) fundamental agricultural, biological, computational, and environmental science and 5 6 engineering, including advanced crop science, 7 crop protection, breeding, and biological pest 8 control, in collaboration with the program au-9 thorized under section 306 of the Department 10 of Energy Research and Innovation Act (42) 11 U.S.C. 18644);

(C) integrated natural resources and the
energy-water nexus, including in collaboration
with the program authorized under section
1010 of the Energy Act of 2020 (enacted as division Z of the Consolidated Appropriations
Act, 2021 (42 U.S.C. 16183));

(D) advanced biomass, biobased products,
and biofuels, including in collaboration with the
activities authorized under section 9008(b) of
the Farm Security and Rural Investment Act of
2002 (7 U.S.C. 8108(b));

23 (E) diverse feedstocks for economically and
24 environmentally sustainable fuels, including
25 aviation and naval fuels;

1	(F) colocation of agricultural resources and
2	activities and ecosystem services with diverse
3	energy technologies and resources, such as geo-
4	thermal energy, nuclear energy, solar energy,
5	wind energy, natural gas, hydropower, and en-

14	(I) long-term and high-risk technological

18	ration with the program authorized under sec-
19	tion 5012 of the America COMPETES Act (42
20	U.S.C. 16538);
21	(J) grid modernization and grid security;
22	(K) rural technology development, includ-
23	ing manufacturing, precision agriculture tech-
24	nologies, and mechanization and automation
25	technologies; and

(L) wildfire risks and prevention, including
 the power sector's role in fire prevention and
 mitigation and wildfire impacts on energy infra structure;

5 (2) develop methods to accommodate large vol-6 untary standardized and integrated data sets on ag-7 ricultural, environmental, supply chain, and eco-8 nomic information with variable accuracy and scale;

9 (3) promote collaboration, open community-10 based development, and data and information shar-11 ing between Federal agencies, National Labora-12 tories, institutions of higher education, nonprofit in-13 stitutions, industry partners, and other appropriate 14 entities by providing reliable access to secure data 15 and information that are in compliance with Federal 16 rules and regulations;

17 (4) support research infrastructure and work18 force development as the Secretaries determine nec19 essary; and

20 (5) conduct collaborative research, development,
21 and demonstration of methods and technologies to—
22 (A) improve the efficiency of agriculture
23 operations and processing of agricultural prod24 ucts; and

(B) reduce greenhouse gas emissions asso ciated with such operations and such proc essing.

4 (d) AGREEMENTS.—In carrying out the activities
5 under subsection (a), the Secretaries are authorized to—
6 (1) carry out reimbursable agreements between
7 the Department of Energy, the Department of Agri8 culture, and other entities in order to maximize the
9 effectiveness of research and development; and

10 (2) collaborate with other Federal agencies as11 appropriate.

12 (e) REPORT.—Not later than two years after the date 13 of the enactment of this Act, the Secretaries shall submit 14 to the Committee on Science, Space, and Technology and 15 the Committee on Agriculture of the House of Representa-16 tives, and the Committee on Energy and Natural Re-17 sources and the Committee on Agriculture, Nutrition, and 18 Forestry of the Senate, a report detailing the following:

(1) Interagency coordination between each Federal agency involved in the research and development
activities carried out under this section.

(2) Potential opportunities to expand the technical capabilities of the Department of Energy and
the Department of Agriculture.

25 (3) Collaborative research achievements.

(4) Areas of future mutually beneficial suc cesses.

3 (5) Continuation of coordination activities be4 tween the Department of Energy and the Depart5 ment of Agriculture.

6 (f) RESEARCH SECURITY.—The activities authorized 7 under this section shall be applied in a manner consistent 8 with subtitle D of title VI of the Research and Develop-9 ment, Competition, and Innovation Act (enacted as divi-10 sion B of Public Law 117–167; 42 U.S.C. 19231 et seq.).
