17	under subclause (I) is not objected to

22	mined by the Secretary;";

24	(as so designated), by striking "The Secretary" and
25	inserting the following:

1	"(1) In general.—The Secretary";
2	(5) in paragraph (1) (as so designated)—
3	(A) by inserting before subparagraph (B)
4	(as so designated) the following:
5	"(A) consistent with the conservation of
6	soil, water quality, and wildlife habitat—
7	"(i) managed harvesting and other
8	commercial use (including the managed
9	harvesting of biomass), in exchange for a
10	reduction in the annual rental rate of 25
11	percent for the acres covered by the activ-
12	ity, except that in permitting those activi-
13	ties, the Secretary, in consultation with the
14	State technical committee established
15	under section 1261(a) for the applicable
16	State, shall—
17	"(I) develop appropriate vegeta-
18	tion management requirements;
19	"(II) subject harvesting to re-
20	strictions during the primary nesting
21	season for birds in the area, as deter-
22	mined by the Secretary, in consulta-
23	tion with the State technical com-

2	occur more frequently than once every
3	3 years on the same land; and
4	"(IV) not allow more than 1/3 or
5	the acres covered by all of the con-
6	servation reserve program contracts o
7	the owner or operator to be harvested
8	during any year; and
9	"(ii) grazing, in exchange for a reduc-
10	tion in the annual rental rate of 25 percent
11	for the acres covered by the activity, except
12	that in permitting that grazing, the Sec-
13	retary, in consultation with the State tech-
14	nical committee established under section
15	1261(a) for the applicable State, shall—
16	"(I) develop appropriate vegeta-
17	tion management requirements and
18	stocking rates, based on stocking
19	rates under the livestock forage dis-
20	aster program established under sec-
21	tion 1501(c) of the Agricultural Act of
22	2014 (7 U.S.C. 9081(c)) (referred to

in this subsection as the 'livestock for-

age disaster program'), for the land

13	year in which grazing is per-
14	mitted that grazing should be al-
15	lowed to occur;
16	"(III) not allow grazing to occur
17	more frequently than once every 3

21	that covers more than 20 acres, not

21	graph (1)(A) shall be subject to the following restric-

23	``(A) Severe or higher intensity
24	DROUGHT.—Land located in a county that has
25	been rated by the United States Drought Mon-

1 itor as having a D2 (severe drought) or greater 2 intensity for not less than 1 month during the 3 normal grazing period established under the 4 livestock forage disaster program for the 3 pre-5 vious consecutive years shall be ineligible for harvesting or grazing under paragraph (1)(A) 6 7 for that year. 8 "(B) Damage to vegetative cover.— 9 The Secretary, in coordination with the applica-10 ble State technical committee established under 11 section 1265(a), may determine for any year 12 that harvesting or grazing under paragraph 13 (1)(A) shall not be permitted on land subject to 14 a contract under the conservation reserve pro-15 gram in a particular county if harvesting or grazing for that year would cause long-term 16 17 damage to the vegetative cover on that land. 18 "(C) STATE ACRES FOR WILDLIFE EN-19 HANCEMENT.—The Secretary, in consultation 20 with the State technical committee established 21 under section 1261(a) for the applicable State,

"(C) STATE ACRES FOR WILDLIFE EN-HANCEMENT.—The Secretary, in consultation with the State technical committee established under section 1261(a) for the applicable State, may allow grazing or harvesting in accordance with paragraph (1)(A) on land covered by a contract enrolled under the State acres for wildlife enhancement program established by the

1	Secretary or established under section 1251()
2	through the duration of that contract, if graz-
3	ing or harvesting is specifically permitted under
4	the applicable State acres for wildlife enhance-
5	ment program agreement for that contract.
6	"(D) Conservation reserve enhance-
7	MENT PROGRAM.—The Secretary, in consulta-
8	tion with the State technical committee estab-
9	lished under section 1261(a) for the applicable
10	State, may allow grazing or harvesting under
11	paragraph (1)(A) to be conducted on land cov-
12	ered by a contract enrolled under the conserva-
13	tion reserve enhancement program established
14	by the Secretary under this subchapter or
15	under section 1231A, if grazing or harvesting is
16	specifically permitted under the applicable con-
17	servation reserve enhancement program agree-
18	ment for that contract.".
19	(c) Harvesting and Grazing.—Section 1233 of
20	the Food Security Act of 1985 (16 U.S.C. 3833) is
21	amended by adding at the end the following:
22	"(e) Harvesting and Grazing.—
23	"(1) IN GENERAL.—The Secretary, in consulta-
24	tion with the State technical committee established
25	under section 1261(a) for the applicable State, may

permit harvesting and grazing in accordance with subsection (b) on any land subject to a contract under the conservation reserve program.

"(2) Exception.—The Secretary, in coordination with the applicable State technical committee established under section 1261(a), may determine for any year that harvesting or grazing described in paragraph (1) shall not be permitted on land subject to a contract under the conservation reserve program in a particular county, or under a particular practice, if harvesting or grazing for that year in that county or under that practice, as applicable, would cause long-term damage to vegetative cover on that land."
